FOREWORD

This report aims at providing an overview of the activities that UNIDO ITPO Italy implemented in the framework of the project "Fostering international partnerships between companies and/or institutions operating in the energy and environment sectors" (hereafter FIPEE) in the period April 2020/January 2021 (10 months totally).

More specifically, the report will start with an introduction of the several initiatives undertaken by this Office in the six target countries involved in the project, i.e. Botswana, Cuba, Ethiopia, Kenya, Kazakhstan and Peru (Iran is still on stand-by), with a focus on how the activities have been changed and adapted to the new work environment due to covid-19 pandemic. In addition, this document intends to outline the main outputs reached in the considered timeframe and most importantly the increase of awareness about the overall project among Italian and foreign Small and Medium-sized Enterprises (SMEs) as well as other project stakeholders.

Before entering into activities' details, it is worth reminding here what are FIPEE project purposes and its interrelated approaches, aspects that UNIDO ITPO Italy has considered when organising the activities.

The overall objective of the project is to support commercialization and scale-up of sustainable energy and environmental technologies and projects in SMEs in the partner countries through promotion of investment and trade.

The project's objective will be achieved by:

- mentoring businesses and projects,
- helping SMEs build capacity and
- facilitating access to financing.

The services offered will be tailored to specific markets and open avenues for SMEs to grow and upscale.

At the same time, UNIDO will work with partners to establish and strengthen markets. The market intelligence gathered together with regional or global best practices and norms inform the shaping of the demand and market pull. This, in turn, will create demand for technology facilitation, innovation, commercialization, entrepreneurship and up-scaling.

The two main interrelated approaches of the project are:

- 1. Providing technical assistance to identify and develop high-impact innovations and investment projects in SMEs in the sustainable energy and environment sector
 - a. Baseline data gathering and analysis conducted
 - b. Identify sustainable energy and environmental technology innovations and projects in SMEs in the seven partner countries
 - c. Develop innovations and projects into a well-structured investment opportunity through dedicated expert coaching and mentoring
 - d. Facilitate policy dialogues, knowledge creation and linkages between the sustainable energy and environmental technology projects and other international partners

2. Facilitating investment, commercialization and trade opportunities through international partnerships and collaboration

- a. Provide dedicated matchmaking services for SMEs with innovations and projects in the seven countries with potential partners and investors in Italy and elsewhere
- Offer curated networking opportunities among SMEs from the seven countries and Italy and other countries in similar fields to discuss product co-development, joint venture and investment, trade, and collaboration opportunities in a business-tobusiness context
- c. Facilitate knowledge exchange and transfer among policy makers from the seven countries and Italy to discuss best-practices and lessons is supporting energy and environmental technologies in SMEs

It is the ambition of this report to help the Italian Ministry of Environment, Land and Sea to understand the entire project scenario and how UNIDO ITPO Italy carried out past activities and planned new initiatives for the forthcoming months for all target countries.

OVERALL ACTIVITIES

Due to **covid-19 pandemic outbreak** and its devastating consequences worldwide, UNIDO ITPO Italy had to review and adjust the core activities previously planned. In particular, valuable business delegation trips, on-site visits and the participation to international trade fairs were no longer possible for health and safe purposes. In order to face these challenges, but at the same time ensure project's outputs, UNIDO ITPO Italy used **digital tools**, wherever possible.

Output 1

1.1 Baseline data gathering and analysis conducted

Since the inception on-site mission could not take place, UNIDO ITPO Italy carried out digital activities from April to October 2020 focused on gathering accurate pieces of information in each target country through:

- mapping the opportunities in renewable energies and environment in each target country;
- identifying the main needs/requirements in terms of technologies;
- analysing the market context and trends;
- identifying the investment climate and incentives provided to foreign investors.

In this way, it was possible to identify the key sub-sectors for energy and environment in each target country as well as to point out the nexus with other sectors like water-food-energy. (Annex 9: "Why invest" presentations). The below table shows in a schematic way the strategic segments where is worth to focus in each country:

2.1 Business and investment opportunities in Italy and partner countries promoted



"Doing Green Business" webinar series, 23 September – 28 October 2020

UNIDO ITPO Italy organized a webinar series named "Doing Green Business" between the 23rd September and 28th October2020. It was a six week thematic country presentations - each one dedicated to a single target country – with the purpose of promoting sustainable investments, technology transfer opportunities as well as brief interested parties about the incentives in the renewable energies and green technologies in the target countries.

Each episode provided a virtual matchmaking platform for the exchange of technical knowledge and experiences, facilitating potential industrial partnerships and trade collaborations in the field between Italy and the partner countries.

The initiative involved **170** participants (Annex 1: list of participants) belonging to business and institutional network as follow:

42 Institutional and business representatives - from Italy and focus countries - took part as speakers in the series (excluding ITPO Italy staff).

The webinar series "Doing Green Business" were essential to provide a better understanding of actual opportunities, technological needs in each Country, economic and financial background, investment trends and incentive schemes.

The initiative also helped to:

- a. integrate the database with selected local and Italian stakeholders operating in the renewable energy and green technology sectors;
- b. strengthen synergies and exchanges of contacts on climate change related issues (part of core activities of UNIDO ITPO Italy office);
- c. manage institutional and business contacts for the future project's activities and events linked to this project.

Delegate Programme

The Delegate Programme is an essential tool for UNIDO ITPO Italy to support investment promotion and technology transfer operations. The Delegate, accurately selected by UNIDO ITPO Italy, is a representative of a developing country whose activity is to promote a portfolio of investment opportunities of the country he/she represents.

In the past, the delegate used to travel to Italy and directly meet and interact with local stakeholders, visit companies and the business community to whom address the investment and business opportunities available in the home country. In 2020, due to covid-19 the Delegate Programme, was conducted entirely online, and it was key to continue promoting investment and business opportunities and represented also a good example of digital transformation strategy.

The delegate was from Ethiopia and in the two weeks (from 30th November to 14th December 2020, see "Ethiopia" session for further details) several online meetings and presentations were held.

It is worth mentioning here that currently UNIDO ITPO Italy is selecting a representative from Botswana in order to organise a new digital delegate programme also in 2021.

2.1.6 Organize the participation of an incoming institutional and business delegation from the selected countries to specialized fairs

Ecomondo 2020, green technology expo from 3rd to 15th November 2020

It was initially planned the incoming of two business delegations, one from Ethiopia and one from Kenya, to the fair Ecomondo that was supposed to be held in Rimini. Afterwards, the fair organisers changed the modality of the event, passing from a physical fair to a digital trade show. With this new pattern, only the delegation from Kenya participated (more details available in the section 'Kenya' of this report). Ethiopia delegation was not able to participate due to some issues related to internet connectivity/availability.

2.1.8 Ensure visibility to the project activities

In order to disseminate all pieces of information and results regarding the project activities on a continuous basis, the following actions have been carried out:

Designing and development of project website and matching platform

The website with information regarding the project, the opportunities promoted and the activities carried out are published at the following link **www.unido.it/FIPEE**. This section has been designed and developed since August 2020.

The website features key data on the project includes: descriptive paragraphs of the main types of renewable energies and environmental technologies; a section for investment and business opportunities; news and events. In addition, the main geographical and economic characteristics of the partner countries are summed up as well as their renewable energy and environmental technologies landscape. The last section is dedicated to links to the recordings of the virtual events and other useful material on legislative framework and investment guides.



The **Investment Opportunities** page shows the portfolio of the IIPP projects in promotion.

The **matchmaking** section will be finalized and published, once all the local technologies identified are uploaded.

Between August 2020 and January 2021, the website has been visited by more than **1,000 users** that navigated more than **5,600 pages.**

Italia-Africa Business Week 2020

UNIDO ITPO Italy took part in the 2020 edition of the Italia Africa Business Week titled "Rebranding Italy in Africa", by joining the panel discussion "Circular Economies, Green Industries and Sustainability in Africa" (on 10th November 2020).

The intervention focused on African countries such as Kenya, Botswana and Ethiopia regarding the project, in order to provide the participants with in-depth information and project's main goals and activities.

2.2.1. Maintain relations with local partners in order to assess the business climate and private sector development in the relevant sectors

Energy and Environment projects' identification through the UNIDO initiative "Innovative Ideas and Technologies vs. COVID-19: A Global Call for Developing Countries" – April-June 2020

During 2020, most of the efforts of UNIDO and its network of field offices were focused on the global fight to overcome the coronavirus, working with strategic partners in order to address the crisis (UNIDO Covid-19 response).

The Global Call "Innovative Ideas and Technologies vs. COVID-19 and beyond", inspired by ITPO Italy and promoted by UNIDO through its network of ITPOs, Investment and Technology Promotion Offices around the world, was aimed at identifying scalable solutions to cope with the direct and indirect impact of COVID-19 in developing countries and economies in transition, and their respective needs in the transition to post-crisis socio-economic realities in the aftermath of the pandemic.

The Global Call offered an opportunity at international level to identify and promote innovative solutions contributing to tackle COVID-19 effects in developing countries and make their economies more resilient, in alignment with the UN Sustainable Development Goals (SDGs). Specifically, priority was given to 4 strategic categories, including the "Energy and Environment" category.

In this framework, UNIDO ITPO Italy took this opportunity to join UNIDO headquarter by combining two main objectives: achieve the UNIDO Global Call goals and, most of all, give a new emphasis and strength FIPEE project's activities. As matter of fact, UNIDO ITPO Italy promoted the UNIDO Global Call among **42** stakeholders of target countries, collecting **7 project applications for the "Energy and Environment" category from Botswana (2 projects) and Kenya (5 projects).**

The delegation of the Ministry of Foreign Trade and Investments (MINCEX) involved in the roadshow was led by the Director General of Foreign Investments, Mrs. Déborah Rivas Saavedra, who delivered a presentation on the Cuban economic system to representatives of the Italian business community, focusing on agribusiness and renewable energy.

Within the round table discussions, the MINCEX delegates had the opportunity to meet with Italian institutional and business stakeholders, to provide them with an overview of the investment climate and opportunities in Cuba.

Around **200** Italian companies attended the presentations and it was also a good opportunity to introduce the project "FIPEE" and invite the entrepreneurs to attend the II Trade Fair on Renewable energy "Feria de Energias Renovables". The fair was scheduled to be held in La Habana, from 10 to 12 June 2020.

UNIDO ITPO Italy contacted several Italian companies by e-mail, newsletters and phone calls presenting the FIPEE project in Cuba as well as the opportunities in biomass, solar, wind and water treatment. The commitment of the Italian business community was demonstrated with the confirmation till March 2020 of 3 Italian companies who applied to participate at the Forum.

Unfortunately, the mission was cancelled due to the pandemic, which caused the disruption on missions and in-person activities.



Webinar "Doing Green Business in Cuba" – 28 October 2020

The virtual country presentation "Doing Green Business in Cuba" took place on the 28th October 2020 aimed at promoting investment opportunities and incentives in the local sectors of renewable energies among Cuban and Italian institutions and SMEs in the field.

The panel discussion focused, among other things, on policies, priorities and ongoing projects of the local ministry of environment in the field of renewable energies.

The webinar saw the participation of several Cuban institutions and relevant stakeholders, was attended by **20** participants and provided a platform for the exchange of technical knowledge and

insights, aimed at facilitating potential partnerships between Italian and Cuban SMEs in the energy and environment sectors.

Thanks to the webinar, **15** investment opportunities in energy and environment sectors have been identified and are ready to be promoted.

Indeed, their common goal is to ensure water, energy and food supply for all, not only in the urban centres, but above all in the rural areas, where people suffer most from frequent droughts and famines.

- Managing relations with the identified Italian and local stakeholders, such as Ministries, institutions, universities, private sector, sectoral associations and business communities as well as international organizations, mainly focused in the energy and environment sectors.

The webinar gathered more than **40** virtual participants, from both the public and private sector.

The initiative contributed to facilitate matchmaking between Italian and Kazakh stakeholders and receive concrete feedbacks on the most promising sectors as well as enhancing the institutional and business contacts already collected in recent months and give continuity to the project's activities. In this scope, Kazakh Invest and the Embassy of the Republic of Kazakhstan in Rome significantly contributed to give inputs and provide useful insights.

In the framework of the event, follow up activities have been carried out and more than **30** companies have been engaged to promote Kazakhstan and its opportunities as well as to support the commercialization and scale-up of alternative, eco-friendly energy sources and innovative environmental technologies for sustainable development in the country.

Furthermore, as part of the follow up, some opportunities were identified in the waste-to-energy sector, where the local company **Planet Care Management** has been put into contact with two Italian companies, **Bonatti S.p.A. e Carlo Gavazzi Impianti S.p.A.**, in one B2B meeting to discuss about potential synergies for the realization of waste-to-energy plants in Shymkent and Almaty.

The tender for the implementation of these waste-to-energy plants will be issued in 2021 and the aforementioned counterparts are still discussing about potential cooperation.

Conference "Market access in Kazakhstan in the sustainable energy sector" – 20 January 2021



In accordance with the national strategy *Kazakhstan-2050* and the *Concept for transition to Green Economy*, the Republic of Kazakhstan introduced a centralized auction mechanism for selecting renewable energy projects, which is aimed at choosing the best projects at the lowest prices. Renewable energy auctions took place in November and December 2020, monitoring and promotional activities have been performed and local winners of the tenders have been identified. This selection was referred to wind power, solar power and small hydro power plants to be realized in the near future.

The virtual event "Market access in Kazakhstan in the sustainable energy sector" was held on 20th January 2021, with the support of the Italian institutional representatives and the Italian business community in Kazakhstan, aimed at: offering to the Italian companies detailed contents on how to access the Kazakh market in the sustainable energy sector; ensuring continuity to the project activities in Kazakhstan; enhancing local contacts both with institutions and businesses.

Bringing together prominent Kazakh and Italian institutional and business stakeholders in the field, the online conference explored opportunities for cooperation in the Kazakh sectors of renewable energies, energy efficiency and innovative eco-friendly technologies. In addition, success cases of

Italian companies operating locally were also shown so as to promote business synergies between Italy and Kazakhstan.

The initiative gathered more than **125** registrations and over **75** virtual participants (Annex 5: List of participants) and it was a useful platform to facilitate knowledge-exchange about investment opportunities (Annex 6: Questionnaire's results).

As part of the follow up activities, exploratory virtual meetings and calls with new Kazakh and Italian companies as well as institutional stakeholders have been scheduled in the forthcoming weeks.



Virtual attendance of a Kenyan business delegation to Ecomondo - November 2020

UNIDO ITPO Italy was the focal point in the framework of the participation of Kenyan companies in occasion of the 2020 edition of Ecomondo and Key Energy, an international exhibition for green technologies, renewable energy and circular economy. UNIDO ITPO Italy liaised with relevant counterparts in Kenya to disseminate information on the event among Kenyan companies, promoting this opportunity among relevant institutions and associations, e.g. the Kenya Investment Authority, the Kenya Association of Manufacturers, the Kenya Renewable Energy Association, the Kenya National Chamber of Commerce and Industry and the Embassy of Kenya in Rome.

Notably, UNIDO ITPO Italy supported the representatives of the companies selected as part of its delegation in the process of organizing their attendance to the event. However, in late October, the exhibition was cancelled due to the spike of COVID-19 cases in Italy and the event was reformulated in the format "Ecomondo and Key Energy Double Digital Green Week", to be held online from 3 to 15 November.

In this context, UNIDO ITPO Italy facilitated and coordinated the virtual participation of a business delegation composed of representatives of two Kenyan companies, namely Wanergy Africa and Strauss Energy, that had the opportunity to actively engage with exhibitors and technology providers, for a total of **8 virtual B2B meetings** held on the virtual matchmaking platform of the event.

Organization of B2B meetings as a follow-up activity to Ecomondo – December 2020-January 2021



As a follow-up activity to the support provided to the Kenyan company Wanergy Africa during their participation in the 2020 edition of Ecomondo, UNIDO ITPO Italy organized a number of B2B meetings with the goal of promoting investment opportunities for Italian companies in the environmental technology sector of Kenya.

Wanergy Africa is a Kenyan company interested in exploring innovative solutions to be applied in the local waste-to-energy sector, with a specific focus on mixed municipal solid waste. Notably, on 9 and 10 December 2020, UNIDO ITPO Italy organized two B2B meetings between Wanergy Africa and two Italian enterprises, namely IES Biogas and Termomeccanica Ecologia.



On 18 December 2020, a third B2B meeting was held between Wanergy Africa and the Italian engineering company MORE for the Planet. Furthermore, on 26 January 2021, UNIDO ITPO Italy organized and hosted a B2B meeting between Wanergy Africa and W.T.E. Waste To Energy, an Italian company providing a wide range of services, from conceptual and feasibility studies, to engineering, procurement and construction management.

The B2B meetings represented an opportunity for Wanergy Africa and the Italian companies involved in this activity to discuss innovative and environmentally-sound solutions in the waste-toenergy sector, laying the foundations for potential partnerships and technology transfer opportunities.

As a follow-up, UNIDO ITPO Italy is following the exchange of information between the companies involved in the meetings.



CONCLUSIONS

Covid-19 pandemic has changed the world scenario and it has affected -and keeps on hurting – the investment and business activities and set new priorities (economic, social and health) among all companies worldwide, not only the Italian ones.

UNIDO ITPO Italy had to face these challenges just like others. However, the office was very fast in adapting to the changes and the team was able to carry out in virtual mode all the activities. Naturally, the response to changes is not equal for all and, especially in developing countries, the digital gap even to perform simple activities can require longer time.

As matter of fact, some target countries faced issues mainly due to lack of internet connection, the scarcity of information on how to use web technologies and/or present investment opportunities in a virtual way or simply unavailability of some platforms (i.e. Zoom). Despite all such constraints, UNIDO ITPO Italy was able to ensure significant outputs of "FIPEE" as project above depicted and it has already planned new initiatives to keep on fostering the business and investment opportunities in environment and energy industries.

The potential identified in the past months in all the target countries is quite encouraging and 'unchartered waters' still have to be explored. The interest raised among the business communities of all countries involved in the projects, Italy included, in very high and promising and UNIDO ITPO Italy can rely on a strong network and capabilities as so to ensure additional concrete results of the project.













